- c) Establishment of a Medical College with **100 (Hundred)** admission capacity MBBS course at **Satara** is feasible.
- d) Adequate clinical material as per the National Medical Commission norms is made available by the institution.

It is further certified that in case, the Government of Maharashtra fails to create infrastructure for the medical college, as per NMC norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government.

CONSENT OF AFFILIATION

On the basis of the report of the Local Inquiry Committee, the Maharashtra University of Health Sciences, Nashik has agreed, in principle, to affiliate the proposed medical college to be established as **Government Medical College, at Civil Hospital Campus, Opp. Satara, Dist. Satara, Government of Maharashtra** with annual intake for **100** seats, subject to grant of permission by the National Medical Commission under/Section 26 of the National Medical Commission Act, 2019 (30 of 2019).
